- V. CHIEF'S REPORT
 - a. During the heatwave, the emergency staff throughout King County were overwhelmed. There were 739 calls, compared to an average call level of 236 calls.
 - b. The District's Aid Car was in the shop for repairs on the air conditioner.
 - c. The Rehab unit filled 95 SCBA tanks for South King County.
 - d. PIO, Eric Autry, was on-call for Zone 3 for the holiday weekend for the 4th.
 - e. On July 2nd, the District hosted a press conference on fireworks and the impact on the community.
 - f. The District had two calls for two small brush fires on July 4th.
 - g. There were 327 calls for service, and the most significant fire was at the Burien strip mall.
 - h. Recruitment update: Graduation to be held on July 15th for the KCVFA #5 class at South King County Fire Training Consortium Auditorium.
 - i. Staffing update: Firefighters Sanchez, Neff and Reed are moving on to career positions with other fire departments. Firefighters Eaden and Connor are our new career firefighters here at the District.
 - j. Levy Lid Lift update: Chief Hicks will provide information at West Hill's Community Association's quarterly meeting on July 20th. He plans to set up Q&A night 2-3 weeks before the October 13th ballots are mailed.
 - k. Health and Safety Fair will be held on Saturday, August 28th on the District's drill grounds. There are 12 commitments for participating vendors.
 - 1. The District firefighting staff attended a virtual meeting with Lt Flohr. Discussion was about how the sheriff's office responds during dispatched calls. There may need to be amendments to the house bill in the future.

- b. Reimbursement was received for 2020 wildfires. Equipment costs for reimbursement are pending.
